3. Supervision Activities of the Board over the Executive Board:

In the first six months of 2025, in the domestic production and livestock sectors, the selling prices of key agricultural, forestry, and aquatic products generally continued their upward trend. Thanks to a relatively stable domestic and export market, producers remained profitable, leading to increased investment in production. The output of crops, livestock, forestry, and aquatic products harvested during the period recorded a considerable increase compared to the same period last year.

However, according to statistics, the epidemic situation began to show signs of rising in the first half of 2025. African swine fever re-emerged in several localities, significantly impacting the Company's business operations, especially in its subsidiaries. Although the Company made efforts to improve sales by enhancing communications, marketing, brand recovery, and actively conducting R&D and product innovation, performance at these subsidiaries remained below expectations.

Based on the above, the Company's business results for the first six months of 2025 were as follows:

- Net revenue from sales of goods and services reached VND 48,965,241,893, equivalent to 39.43% of the 2025 target.
- Net profit after tax was VND 3,092,085,530, equivalent to 60.64% of the 2025 target.

However, the increase in net profit after tax during the period was mainly due to other income, amounting to VND 2,660,465,239, resulting from technical support provided by customers. Additionally, signs of positive recovery in the domestic macroeconomic environment helped boost net revenue at the Company's head office by VND 1,683,393,155 compared to the same period last year.

In summary, although the Company's core business activities showed signs of decline due to market and livestock sector impacts, the total net profit after tax in the first half of 2025 still recorded a significant increase thanks to the unexpected additional income.

From the beginning of 2025, the Board of Directors (BOD) has organized periodic meetings to evaluate the production and business situation and review the financial reports and operating plans submitted by the Executive Board. In addition, thematic meetings were held when necessary to address arising issues in plan implementation. The BOD issued resolutions related to the business plan, revenue and profit targets, and implemented a monthly/quarterly monitoring mechanism for the Executive Board. Key monitoring contents included:

- Revenue, sales volume, and customer receivables;
- Cost efficiency, especially selling and administrative expenses;
- Effectiveness in utilizing existing assets, such as the premises at 88 Truong Chinh;
- Monitoring disbursement progress, financial payments, and budget indicators;
- Timely assessment and feedback to the Executive Board upon detecting major fluctuations in cash flow or expenses.

The BOD continues to accompany the Executive Board in strategic restructuring and reorienting the operating model where necessary, while also considering adjustments to targets in line with current market conditions. With this approach, the BOD believes that, through collective effort across the organization, the Company will soon overcome this challenging period and return to a sustainable growth trajectory. The BOD remains committed to strengthening its supervisory role and supporting the Executive Board in restructuring business operations, helping the Company navigate market challenges and maintain stability and sustainable development in the upcoming periods.
